Mr Phil de Joux Chief Corporate Affairs Office - Lyttleton Port Company (LPC)

Phil is a Christchurch resident and has two teenage daughters. He has wide ranging duties in his role including covering all consents and environmental issues.

His address included a number of significant growth factors within LPC as follows:

-

Last year Christchurch was the third largest container port in NZ, after Auckland and Tauranga.

-

LPC employs 650 staff.

-

One of the growth areas is with the new cruise berth, allowing very large cruise vessels to dock at LPC, with 80 cruise vessels last year and 85 expected this next year. This compares with Auckland which has to anchor the cruise ships and tender the passengers in to shore.

-

The revenue from LPC last year was close to \$190M which enabled a quite large dividend to be paid to the sole owner, ie, Christchurch City Holdings.

-

Currently 450,000 containers are handled each year by LPC. The containers are owned by the shipping company and stored by LPC at two sites, namely: the Woolston, Christchurch site and the Rolleston depot (Midland Port). They plan in future to develop another container terminal, very likely in the north of the city.

-

The container ships are getting bigger each year, and now the large ones carry up to 6,500 containers.

-

There is a need for ongoing dredging of the container berth area and the entry channel to a depth of 14.5 metres at all times.

-

Much of the recent expansion has been done through earthquake insurance payouts, but now the capital has to be generated by LPC itself.

-

There is a plan to extend the container terminal, developing 16 hectares of

land in two stages, with an aim to double the number of containers to around 950,000 per annum within the next 10 years.

- There is also a plan to reduce the emissions from LPC by 50% by 2030. In summary, Phil presented a very comprehensive overview of LPC and the significant growth prospects they have generated to date and plan to generate in the short term. We reiterate at that LPC is a wholly owned subsidiary of Christchurch City Holdings generating significant dividends on behalf of the Christchurch rate payers. Phil's address was very well received and further reinforces Lyttelton's place as the hub of the South Island.
